Open Public Comment

Allison Langlois 12427 Lariat Rd. Spearville, KS spoke of their new family business, a pumpkin patch named Hickory Hollow. She spoke of the activities they currently have planned, with the goal to be open in September 2021.

Patrick Klecker with Santa Fe Trail Community Corrections informed the board, Max Bunyan, former Director of SFTCC, passed away last week.

Chairman Tasset read a letter received from Charles Sellens, a member of Dodge City Veterans Counsel, thanking the Ford County Fire / EMS department for helping raise flags at Maple Grove Cemetery on Flag Day.

Unfinished Business

Ford County Fair: Follow –Up / Cost Estimates

This was tabled from 2021-16 and 2021-18 meetings to allow time to obtain expenses for the relocation of the Ford County Fair activates to Western State Bank Expo Center. Jacob Ring, President of the Fair Board and Curtis William Vice - President of Fair Board presented the expense estimates from Conant Construction and Building Solutions. Conant Construction was for \$3,138,688.47. Building Solutions was for \$3,570,677.65. Blattner Feedlot Construction for gates and panels came in at \$117,559.21. After much discussion, Mr. Ring was asked to bring back information on who governs the fair facilities; is it KDHE or Kansas State University? Instruction given to work with the County Administrator and Legal Counsel. Chairman Tasset will meet with Jacob Ring at the current Fairgrounds to tour the grounds after today's meeting.

Legal Counsel

Farm Lease: S 1/2 of Section 22, Township 25 S, Range 25 W

Mr. Glenn Kerbs, Ford County Legal Counsel, discussed the farm lease with B.E. Schneweis, Inc. This current lease was for a period of 5 years, ending May 31, 2019. Lease payments were received and deposited for 2019, 2020 and June 14, 2021. Mr. Kerbs asked what the Commissioners' plans are for the property, and if they want to continue to lease to B.E. Schneweis, Inc?

Chairman Tasset stated we leave it for this year, if the lease has already been paid; assuming they have crops planned and / or planted by this time. The county land should go out for bids on a regular basis. The term of the lease needs to change because the timing does not work out, with regards to farming schedules. It should go out for bids next summer with a lease that would start next fall. Mr. Kerbs will check with the County Clerk on payment years to see if payments were for full year. Will submit, for board approval, the amended lease and bid specs to use next summer.

Stifel, Nicolaus & Company: ARPA Contract

Mr. Glenn Kerbs presented the contract with Stifel, Nicolaus & Company for the oversight and management of funds from the American Rescue Plan Act, (ARPA). This company assisted in the management of the CARES Act, earlier in the year. They are asking for more money to manage this fund than they did for the CARES funds. ARPA funds will cover the fee this for this.

Commissioner Boys moved to approve the contract with Stifel, Nicolaus & Company. Commissioner Snook seconded the motion. **Motion carried 3-0**.

County Administrator's Report

Dodge City/Ford County Development Corporation: Rural Opportunity Zone

Joann Knight, representing Dodge City/Ford County Development Corporation, presented for approval, Resolution 2021-12 Authorizing participation in Rural opportunity Zone Student Loan Repayment Program Calendar Year 2021. This program is offered by the State of Kansas. Ms. Knight explained this is a program Ford County was added to the Rural Opportunity Zone by the State. It offers the opportunity for cities, employers and foundations to assist qualified residents and individuals who move into the county, with student loan repayment. This program is offered by the State of Kansas. The County is not required to pay into this. By the county adopting this resolution, it allow cities and business to participate, if they chose to do so. This is required to be renewed every year.

Chairman Tasset moved to adopt Resolution No. 2021-12; Resolution of the Board of Ford County Commissioners Authorizing Participation in Rural Opportunity Zone Student Loan Repayment Program Calendar Year 2021. Commissioner Snook seconded the motion. Motion carried 3-0.
