DEDICATION

We, the undersigned, do hereby certify that we are the owners and proprietors of the following described tract of land upon which Myers Replat No. 2 of Lot 4, Block 20, and the west 16.0 feet of Lot 3, Block 19, Crawford Addition to Dodge City, Kansas (now vacated) including the vacated intervening street, as determined by legal survey dated January, 1948, is located, being more particularly described by metes and bounds as follows, to-wit: Beginning at the southeast corner of Lot 3, Block 20, Crawford Addition to Dodge City, Kansas (now vacated), as determined by said legal survey, the same being on the north line of Beeson Road; thence east on the north line of said Beeson Road a distance of 300.0 feet; thence north along the west line of the alley adjacent to the west side of Myers Replat of Block 18, 19 & 20, Crawford Addition, for 302.0 feet to an iron pin; thence west for 300.0 feet; thence south along the east line of said Lot 3, Block 20, Crawford Addition for 302.0 feet to place of beginning.

We further certify that all streets, avenues and alleys included in this replat are fully set forth and defined on this plat and are intended to be and are hereby dedicated and/or rededicated to and for public use and purposes as highways.

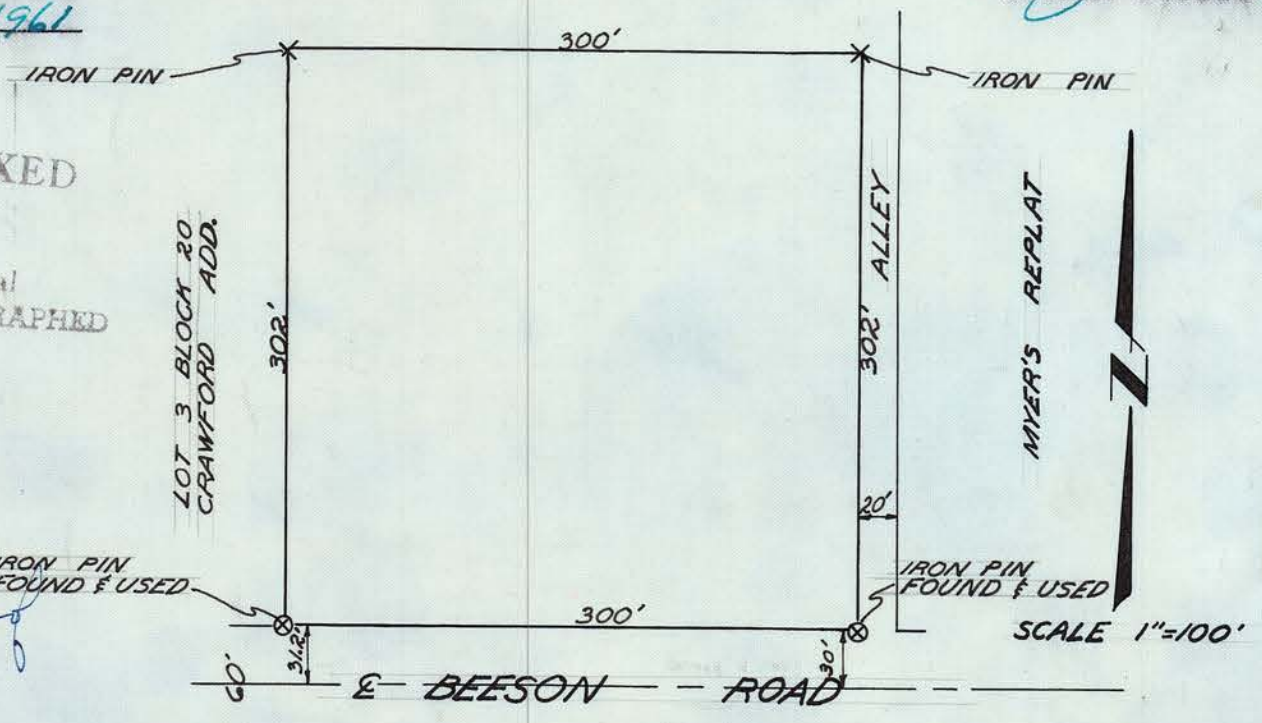

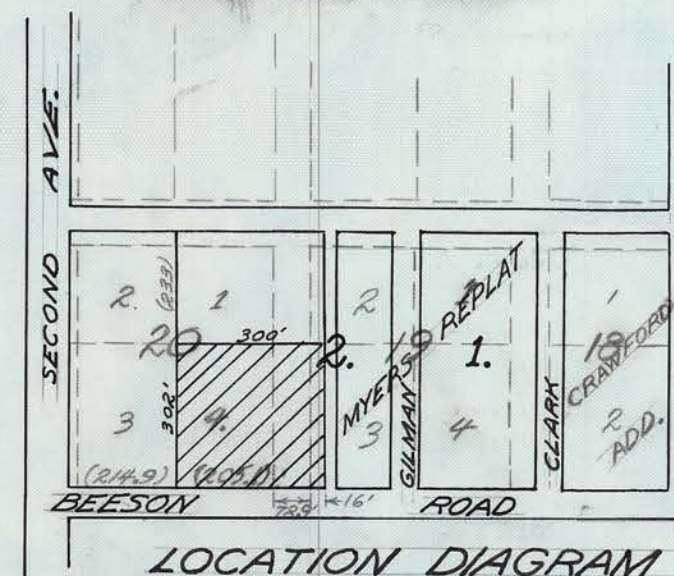
